- Round-trip: PHL to Dallas Fort Worth & then to Gunnison w/ American Airline.
- Round trip: Airport to Grand Lodge.
- Round Trip: Daily 10 minute shuttle every 15 minutes to the Crested Butte Resort.
- 7 night accommodations with mini kitchens at the Grand Lodge, Crested Butte.
